The EU adopted their Delegated Act on Friday 23rd July with the decision – **a 50% slot use rule for Winter for all series of slots held**. Despite huge Member State support for the Airline position – including letters to Commissioners Valean and Hololei stating a 30 – 40% maximum use threshold was in line with the circumstances – DG MOVE had made up their mind and were not moving lower than 50%. BARIN is very disappointed to see the outcome, which is so 'out of touch' with the reality.
