Quarantine lifted for people who only have been in contact with contaminated person

In the latest Corona-press conference Friday evening 14th January, the Dutch Cabinet announced that the current governing quarantine rule no longer needs to be adhered to for people having been in close contact with contaminated people when:

- 1. They have had a booster shot longer than 1 week ago
- 2. They have been tested positive within 8 weeks from being in contact with such person.

BARIN advocates at the Health Ministry that when this regime counts for people residing in The Netherlands, this should also count for people coming to The Netherlands. Hence, we strongly recommend to treat passengers coming from e.g. the USA or the United Kingdom in the same way.
