## FLASH UPDATE 22 FEBRUARY 2022

Dear <<First Name>> <<Last Name>>,

As I said in our Flash Update from a few weeks ago, I am optimistic about 2022!

Travel restrictions have been lifted, and are being lifted while we speak; not only in Europe, but also outside Europe.

The Hague has realized more and more that BARIN is *realistically* defending the interests of our industry. Recovery and Sustainability remain our core priorities.

Having said this, that doesn't mean we are 'OK' with everything.

We have sent a letter (link below) together with many other stakeholders to our Ministers Harbers, Hoekstra and Kuipers to ask them to ensure that traveling from any destination is possible without mandatory testing, at least for those fully vaccinated or recovered from COVID. It's the new reality we have to get used to, and it is also in line with most other EU-countries. I don't understand why, too often over the past two years, the Netherlands is taking a different position in Europe.

the airport charges with 37% for the three years to come, beginning this April 2022. Especially as they have reported a profit of 105 million euros in the most devastating year for the airline industry, 2021. Het Parool: (link below): "Airlines cannot explain that the airport last year, despite corona, reported a 105 mln profit, and increased the tariffs with 37%". No we can't explain, can you?

As you may be aware BARIN, together with many other stakeholders appealed at the ACM (Authority for Consumers & Markets). Their hearing took place on February 11<sup>th</sup> for a full day in The Hague. We expect a decision before April 1<sup>st</sup>. After that we will decide on possible next steps.

In an effort to align all COVID-rules on a European level (which BARIN has been advocating constantly over the past 2 years), we have sent a joint letter to the Ministers of Public Health, Mr. Kuipers, the Minister of Transport Mr. Harbers and the Minister of Foreign Affairs Mr. Hoekstra.
