# Wearing of Face masks in aircraft and at airports to be abolished by 21 May

On Wednesday May 11<sup>th</sup>, the European Aviation Safety Agency (EASA) and the European Centre for Disease Control (ECDC) jointly stated to make a start with further relaxation of COVID-measures. Wearing of face masks at airports and in aircraft is no longer mandatory in EU-member states as of 16<sup>th</sup> May next. This will also be on the agenda in the Dutch Ministers Council of Friday 13<sup>th</sup> May and then sent to the House of Representatives (Tweede Kamer). The expectation is that as per 21 May next, also the Netherlands will formally abolish this requirement.
