Schiphol Airport signals staff shortages at Ground Handling Companies

Amsterdam Airport Schiphol announced to be on track with hiring additional security staff. Recruiting campaigns seem to be successful due to increased remuneration and improved working conditions. However, an ongoing situation of the unfulfilled vacancies at Ground Handling Companies gives Schiphol reason for concern for the entire operation at Schiphol in the Easter, May and Summer holiday periods. Schiphol's interim CEO Ruud Sondag has raised the red flag and calls upon all sector parties to work closely together in making sure that enough staff can safeguard a stable operation. Airlines, security, ground handling companies and border police are chain partners depending on each other.

BARIN submits point of view on Insulation Project Schiphol

In the period from the mid 1980's until 2012 ca. 13.000 houses around Schiphol were insulated in order to defer noise from inside homes and buildings. The Deputy Minister in 2013 stated that the project was finished and no more houses/objects needed to be insulated. The entire Noise Insulation Schiphol projects (GIS1, GIS2 and GIS3) were financed for a large part by the airlines at a cost of some € 750 million. BARIN is therefore opposing to a new initiative to insulate another 660 'objects' which were not insulated at the time and now to be insulated at a cost of an estimated € 40 million, which again is recharged to the airlines.
