The Judge ruled April 5<sup>th</sup> in favour of KLM cs. and IATA cs. in the court case on reduction of air traffic movements. The decision didn't come as a surprise, as the Minister did not at all follow the applicable rules correctly on how to come to such a decision. Therefore it's even more surprising he decided this week to go for an Appeal. On which grounds apart from stating that "the verdict does not respect the interests of the people living around Schiphol" remains a mystery to us.

Disappointing, as I stated before, we all have the same objective: less noise, less  $CO_2$  etc.

The way forward is definitely not to bluntly axe the flights at Schiphol to 460.000 and 440.000. This will have dramatic effect on employment as also the trade unions fear. They handed over a petition to Members of Parliament on Tuesday against the plan of our Government.

From Dubai to Atlanta many are asking why we put our investment climate and thousands of jobs at risk.

## Judge rules in favour of KLM cs. and IATA cs. in court case on reduction air traffic movements

On April 5<sup>th</sup> the Judge at the North-Holland District Court in Haarlem passed the verdict of the case which was held on March 21<sup>st</sup> in which KLM cs. and IATA cs. opposed to the announced reduction of air traffic movements at Schiphol Airport as per November 2023. This was the intention of the Minister of Infrastructure and Watermanagement, Mr. Mark Harbers as communicated in his letter on 24<sup>th</sup> June 2022.
