Already our tenth Flash Update of 2023.

As announced in our last one, we welcome two prominent, new members jetBlue and Air India. Below you will find more information about India's flag carrier.

After more than a year of discussions with management of Schiphol, unfortunately this week we had to inform our members that Schiphol denies time and again any legal and financial responsibility for the lost revenues. Only for a very specific period (May holidays and five 'regulated days' in September last year) they are willing to compensate cost for denied boarding passengers, as per EU regulation EU261/2004.

Disappointing, unfair and an abuse of their monopolistic power. Now it is up to our members if they want to give it a followup. At least Schiphol demonstrated during the recent May holidays that they have learned a lesson; it was a smooth

operation with acceptable waiting times. Also for this summer we expect a fine performance , without any capacity restrictions. Back to normal, while discussions continue on reductions of movements at Schiphol. Lets first wait for the decision of the judge, on the appeal of the Minister against the court decision which said the government was wrong to order Schiphol to reduce the number of landings and take offs.

BARIN welcomes Air India as new member

We are very happy that Air India has decided to join BARIN as they will resume non-stop flights between Delhi and Amsterdam operating a B787-8 Dreamliner with a 4 times per week schedule, starting from June 11th. This brings the total number of Air India flights between India and Europe at no less than 77 per week.

Air India's B787-8 offers 18 lie-flat seats in Business Class and 238 seats in Economy Class. AI155 leaves Delhi at 13:10 in the afternoon on Monday, Wednesday, Friday and Sundays to arrive at 18:35 the same day in Amsterdam. The return flights (AI156) leave Amsterdam at 20:45 in the evening to arrive in Delhi the next morning at 07:55 local time.
