Our last Flash Update was sent on July 12th, 2023. During the past two months a few things happened... Schiphol improved her operation and performed very well during the busy Summer season. Fortunately, because we have clearly seen a huge appetite for travel.

At the same time Schiphol pushed intensively her own plan to reduce flights and called upon Parliament not to declare the reduction of air traffic movements at Schiphol 'controversial'.

It is extremely disappointing and incomprehensible

It is extremely disappointing and incomprehensible that Minister Harbers informed us last Friday that as an caretaker government they have decided to continue with her plan to reduce the number of air traffic movements at Schiphol to 452.500 by Winter'24. And what comes next?

Why pushing this decision in the last weeks in office, why damaging our economy, why hurting

employment and taking an unacceptable risk that other countries might retaliate?

No dialogue took place on the alternative plan the industry presented in June when submitting her point of view for the Balanced Approach, with the same objective, 20% noise reduction at Schiphol Airport. And with an even better outcome on a longer horizon.

Again, we call upon Parliament to reflect on the consequences of the 452.500 air traffic movements, to look into the alternatives, to declare the entire Dutch aviation file "controversial". Act on facts and figures, not on emotion. Don't throw away in one minute what we built up over the course of 106 years!

Dutch Cabinet submits Notification on flight reduction to the European Commission

Last Friday, 1st September the Ministry of Infrastructure & Watermanagement submitted the Notification on the Balanced Approach procedure to the European Commission in relation to the intended reduction of air traffic movements at Schiphol. BARIN stated the she is very disappointed in the fact that a drastic decision like this is taken by an outgoing Cabinet and with elections coming up. At the same time we are also awaiting a verdict from the Supreme Court in a Cassation which is due by the end of this year or latest beginning next year.

Netherlands Labour Authority confirms intended fines and orders Schiphol to fully automate baggage cellars within two years

In the dispute between the Dutch Labour Inspection and Ground Service Handling Agents, the NLA has confirmed the intended fines for not improving working conditions enough in relation to the lifting of baggage by the baggage handlers. The total sum reaches an amount of € 200.000 per month. At the same time the NLA orders Schiphol to speed up the works to fully automate the baggage cellars at Schiphol within the next 2 years.
