Two days later the Attorney General advised the Supreme Court that a so-called Balanced Approach procedure via the European Commission is

One cannot unilaterally, without exploring other options instigate capacity reductions at an airport. It seems a logical advice for many as these are the rules we have agreed upon in Europe.

# **Aviation Sector organizes roundtable with Dutch MP's on 10 Commitments**

Last Wednesday, April 3<sup>rd</sup>, the Aviation Sector united by 31 different parties -ranging from airlines, fuel suppliers, aircraft manufacturers, knowledge institutions and interest groups- who signed the earlier released 10-commitments plan held a very fruitful roundtable session with Dutch Members of Parliament and political party's policy makers from 8 different political parties, including the 4 parties currently holding the talks on a possible coalition. This one-hour discussion offering ample opportunities for sharing visions and asking questions appeared to be very fruitful and was wellappreciated by both sector and MP's. A need for understanding and joint fact-finding and future collaboration is essential for a well-balanced futureproof aviation landscape supporting the Dutch economy.

# Advocate-general advises Supreme Court on Reduction proposal Minister Harbers

The Advocate-general issued an advice to the Supreme Court last Friday, 5<sup>th</sup> April on the first trench of the intended reduction of air traffic movements at Schiphol Airport. In an earlier ruling the Dutch Court already approved the plan by Infrastructure & Watermanagement Minister Harbers for this intended reduction. However the Advocate-general now issued an advice stating that also for the first trench (the Experimental Ruling) a so-called Balanced Approach via the European Commission is mandatory. Whether the ruling is a temporary one or not does not make a difference according to the Advocate-general; in the Balanced Approach notification the Ministry should be able to prove that all other measures to reduce noiseemissions have been investigated but failed to reach the required result.

# Knowledge institute for Mobility-policies (KiM) issues report on preference for nonstop flights

People traveling to and from The Netherlands prefer to do so by using direct flights. An alternative for a direct flights is non necessarily an indirect flight, but can also be another destination or no flight at all, so a different mode of transport.

The larger the distance, the more likelihood there is for taking a indirect flight. Business travellers make more use of a transfer as there are more options available than just using non-stop flights.

## Infrastructure & Watermanagement Minister Harbers announces reduction of Ground Handling Companies at Schiphol

In his 7<sup>th</sup> so called progress-letter on the Program Environment Schiphol, Minister Harbers announces amongst others the reduction of the current number of 6 Ground Service Handling Agents (GSHA's) to a maximum number of 3. However the number of 3 ground handling companies only apply to the servicing of passenger aircraft for baggage- and platform handling. Ground handling of cargo and mail as well as Full Freighter aircraft and General Aviation (private jets) is excluded from this decision. The final decision will be published shortly and thereafter Amsterdam Airport Schiphol will start a market-consultation and European tender process.
