Pre-consultation meetings for the Airport Charges setting 2025-2027 with Amsterdam Airport Schiphol have started.

On Wednesday April 17 and Thursday April 18 we had so-called deep dive sessions on, amongst others the Schiphol Mid Term Plan, the WACC (Weighted Average Cost of Capital), Traffic & Transport, peergroup benchmark charges and quality, and Schiphol's 8-point action plan. More discussions will take place in June and July.

It's fair to say that planning becomes more complicated and difficult due to the current political uncertainty in The Netherlands.

In the formal Consultation meeting on September 26 the airport charges increases for the coming three years will be discussed. We fear again a substantial increase, as Schiphol has to invest in its quality and maintenance. Of course there are limits, of course we don't want to pay for continuous budget overspendings. We will play our role, in close coordination with all stakeholders, including IATA. At least *"discussions*" take place with Schiphol. This is unfortunately the contrary with our Ministry and the Minister on the dossier of the intended reduction of air traffic movements at Schiphol. As of day one, two years ago, when we were totally surprised by his announcement to reduce the movements at Schiphol to 440.000, we were and still are not invited to be part of the process. Time and again we offer to discuss how to define a sustainable future for our industry. Because less noise and less emissions is our joint objective. Time and again, the hand we reach out is being rebuffed.

There are also other European governments -like Sweden- where a more European approach is being pursued. The Swedish Government announced a reduction in ticket taxes in order to avoid stacking of taxes on top of the European aviation taxes. Makes one think.....

Swedish Government announces Reduction of Ticket Tax

In an attempt by the Swedish Government to avoid stacking of Swedish aviation taxes on top of already existing European levies, a reduced aviation tax was announced. Ticket taxes are halved as per 01 January 2025. Tickets from Intra-Europe travel will go down from ~€ 7,50 to € 3,75, tickets to Africa and Turkey are going from ~€ 28,00 to € 14 and taxes to all other worldwide destinations will go from ~€ 44,00 to € 22,00 Please **<u>click here</u>** to find more details.



Number of aircraft noise complaints via BAS remains stable

BAS (Bewoners Aanspreekpunt Schiphol) has issued the annual report on complaints on aircraft noise/nuisance over the period 01 November 2022-31 October 2023. Although the number of aircraft movements increased by 8,3% compared to the same period in the previous year, the number of complaints increased by only 0,9% (from 10.520 to 10.612). Even though this is good news for the sector and the environment, there are still complaints (on specific aircraft types or about traffic in peak-times) and there is still a need and an ambition to further reduce noise hindrance in order to improve the living conditions for all those living around the airport. And this goes for regional airports as well. The Ministry of Infrastructure a& Watermanagement is in consultation with stakeholders to come to a system to further reduce hindrance by aircraft movements.
