Unfortunately we were left with no other option than to summon the Dutch State to court....!

A next logical step, after the 440.000.., the 460.000..., and now the 478.000 ..air traffic movements (6000 below the 484.000 historical slots and 22.000 below the since 2015 applicable 500.000 movements).

Last Monday 14<sup>th</sup> April, the Aviation Sector - represented by Air Transport Association of America (A4A), IATA, BARIN, ACN and carriers KLM-Group, Delta Airlines and TUI- summoned the Dutch State and the Royal Schiphol Group (RSG) to the District Court in Haarlem to challenge the decision of the Minister of Infrastructure and Watermanagement, Mr. Barry Madlener to continue with the implementation of the reduction of air traffic movements (478.000) at Amsterdam Schiphol Airport as per November 2025 (W25/26 season). The lawyers of the airlines argued that the Balanced Approach procedure was not carried out correctly

and the Ministry has constantly ignored the 3 comments of the European Commission. Although the Ministry does not formally need the approval from the EC, the airlines, in accordance with European rules, argued that a capacity reduction at an airport should only be a 'last resort' and state that not all (operational) measures have been explored to the fullest which would make a capacity reduction redundant. The Netherlands would be the only country in the world, where reduction would be the end result.

The lawyers of the State claimed that the Balanced Approach procedure was followed correctly and is now formally concluded. The argument is that there is no need to adapt any policy intentions and there is still ample time for the sector to adapt to reduced number of movements. The lawyers from the RSG argued that they had not needed to be summoned as RSG is simply executing the prevailing law; if an intermediate Air Traffic Decree (LVB) would stipulate 478.000 movements (of which 27.000 night movements), they would request the slot coordinator to declare the capacity likewise. If there would be no intermediate LVB by May 8<sup>th</sup> (deadline publication CapDec W25/26), she would request a Capacity Declaration based on 500.000 (32.000 night) movements from ACNL.

The judge will rule no later than Monday, April 28<sup>th</sup>. Hereafter we will analyse the consequences of the decision.

Another pending case is being reviewed by the Authority for Consumers and Markets (ACM). The ACM prevents companies from abusing their market powering and oversees a.o. our transport sector. Many airlines have strongly objected against the increase of the Schiphol airport charges, with 41% for coming year. We have been informed yesterday by the ACM they need more time to conclude, due the "complexity"

of the various subjects. We expect their decision before May 27, 2025.
