Authority Consumer and Markets rejects industry claim on increase airport charges Schiphol

Following a claim from the aviation sector at the ACM (*Autoriteit Consument & Markt*) on the proposed increase of 41% in 2025 (cumulative 37% over 2025-2027), the ACM has ruled that Amsterdam Airport Schiphol followed the correct procedures to come to this tariff-setting. The ACM's reasoning is that since the airport is only 'covering the costs and not making a profit' the increase of 41% is justifiable. Nowhere in her statement was mentioned that the Aviation Act in which is stipulated that the airport is allowed to recoup previous losses in future years was never intended for a dramatic occasion such as the COVID-19 pandemic where the entire world is confronted with financial losses.... except this airport. BARIN would have expected a more critical note on this. One can ask itself when the ACM declares an increase "unreasonable".....!

Judge declares Nature Permit for Amsterdam Airport Schiphol annulled

In a court-case by environmental interest groups such as Mobilisation for the Environment and others, the judge in The Hague ruled that the nature permit for Schiphol which was granted by the previous Minister of Environment in 2023 is unlawful. The judge stated a.o. that insufficient research has been done in noise pollution and the consequences thereof for animal species with regard to three nature reserves".

This does not mean that immediately flight movements will be reduced at the airport since the current (non-missionary) Deputy Minister of Nature, Rummenie declared Schiphol of (inter)national importance. The issue is mainly related to NOxemissions and buying of emission-rights by Schiphol. In a reaction the Airport stated that the submission of the Nature Permit for the larger part was done correctly, however that the rules for buying the emission-rights have only been stipulated after submission of the nature-permit request and this requires a national government solution. Schiphol has also stated that they will appeal to the ruling.



Largest coalition party PVV leaves Cabinet and new national elections are imminent

The PVV who won the last national elections in November 2023, blew up the current coalition Cabinet by stepping out of it and having all PVV Ministers and Deputy Ministers resign. This led to the fall of the entire (4-party) Cabinet, making new elections necessary. These will be held on October 29th next. What the impact is on the various files related to the aviation sector, such as the new Aviation Act or opening of Lelystad Airport and which files will be declared "controversial" or not will be discussed in a Parliament session on 18th June next.
