Singapore and The Netherlands are comparable in many ways; small in size, large in ambition. Resulting in an impressive GDP per capita!

Both countries are dependent of foreign investments and have created an aviation sector that supports this. Interesting to learn that Singapore has a different attitude towards the airlines related to taxes. No one talks about a transfer tax, as its airlines and airport are very dependent of this traffic.

At the same time as of October 2026 Singapore will impose a sustainable aviation fuel levy on departing passengers varying from Singapore \$1 to \$41, based on distance and travel class. This tax aims to achieve Singapore's target of sustainable aviation fuel constituting 1% of jet fuel by 2026 and 3-5% by 2030. It will be funded by the revenues of the sustainable aviation fuel charge.

Two observations / differences compared to The Netherlands:

- the Singapore tax revenues benefit SAF directly.
  In The Netherlands the revenues of the long distance tax will disappear in the deep pockets of our Minister of Finance to cover the national budget.
- Singapore has a far more realistic target of SAF than the Netherlands. In The Netherlands we aim for a target off 13% by 2030.

Not that long ago Singapore learned its lessons from The Netherlands; today it should be the other way around!

Another example of a different approach is our neighbour Germany. They cancel the planned increase of their aviation tax!.

BARIN is deeply concerned about the government's intention to introduce a so-called long-haul tax. This is especially worrying now that Germany has decided to reverse the increase of this tax. With this decision, Germany is clearly advocating tax relief for airlines and underlining the importance of aviation for the German economy and its investment climate. BARIN calls upon all political parties to - push for realistic SAF targets - aviation taxes should be used to incentivize production & consumption of SAF - don't introduce the long distance tax that will disappear in the pickets of Finance and last but not least don't even think about a transfer tax.

## Kick-off Cabinet Formation by 'Scout' Wouter Koolmees

Last week 'Scout' (Verkenner) and former Minister Wouter Koolmees presented his advice to the Chairman of the House of Representatives after having consulted the leaders of all elected political parties. As there are various options on the table to form different coalition governments being either centre-left of centre-right, the Scout advised the two major winning parties D66 and CDA to continue bilateral talks in order to come to a first agenda on main strategic political topics such as the Nitrogendebate or the housing-issue. Under the supervision of former Minister Sybrand Buma (CDA), talks will continue in the next couple of weeks. Time will tell which other parties are inclined to cooperate in this new coalition cabinet.



### **Updates on Entry & Exit System (EES)**

As of 3 November, the Entry/Exit System (EES) has been introduced at Schiphol with a soft launch. This EU system registers third-country nationals entering or leaving the Schengen area.
