Schiphol's reduced capacity compared to airports in surrounding countries

As per W25/26 schedule (effective 01 November) the capacity at Schiphol Airport is being reduced by the Minister of Infrastructure and Watermanagement from a previous 500.000 air traffic movements per annum to a maximum of 478.00. At the same time we see surrounding countries such as the UK, Spain and Germany investing in the aviation infrastructure to accommodate further passenger growth in the years to come.
